Standard Operating Procedure to be followed for appointment of Assistant Professors on regular basis in the Private Aided Colleges of State of Punjab

- Online applications on the prescribed format shall be invited from the eligible candidates for the posts of Assistant Professors through an open advertisement to be published in newspapers.
- 2. The applicants will be required to fill up the Score Card Proforma(as per Annexure-II),
- 3. The shortlisting committee will be constituted by the University /Government which will be having the following members:
 - (a) Dean College Development Council of the respective University (Chairman)
 - (b) Principal of the Concerned College
 - (c) Senior Most teacher of the concerned college of Concerned subject
 - (d) Dean Faculty of the concerned University/Senior Most teacher of the University of the Concerned subject

(e) Nominee of the Director Higher Education Punjab (Subject Expert) The Process of Shortlisting of the candidates will be completed in the office of the Dean College Development Council of the respective University.

(Note: In Case of regular appointments in the Government Colleges of the State , the procedure of shortlisting of the candidates will be decided by the Punjab Public Service Commission)

- 4. After receipt of applications, shortlisting of the applications shall be done by the shortlisting committee (as per the criteria specified in Annexure-I) to check the documents as well as eligibility of the applicants.
- 5. The shortlisting committee will verify the marks claimed by the applicant in the Score Card and prepare a merit list based on the Verified Score Card.
- 6. The shortlisting committee shall also send recommendation to invite 8 candidates for each first vacancy and 4 candidates for every additional vacancy for the interview as per the order of the merit list.
- 7. The constitution of the Selection Committee shall be as per UGC Regulations 2018 under Clause 5.0 and sub clause 5.1(V) for appointments on regular basis. At least four members, including two external subject experts shall constitute the quorum.
- 8. The final Selection of the candidates will be made by the Selection Committee considering the following parameters as per Annexure. II(a):
 - a) Academic Record and Research Performance and Teaching Experience/Post Doctoral Experience and Awards - [as per score card attached at Annexure – II, the marks secured by applicant as per annexure-II will be calculated for 60% weightage of 100 marks by applying the formula = <u>Marks secured</u> x 60 Maximum marks (100)
 - b) Assessment of domain knowledge by external experts(in a simulated class room set up) 20 % weightage
 - c) Interview 20% weightage

In case the required number of application are not received then the minimum number of applicants to be invited for interview shall be decided by the University/Government.
- 4. The Points awarded to the candidates during the process of shortlisting of applications shall be used for selection process and in interview by theSelection Committee.
- 5. The Period taken by candidates to acquire Ph.D shall not be considered as teaching/research experience to be claimed for shortlisting/appointment.




